SUPPLEMENTARY REGULATIONS

Introduction:

Welcome to the ninth running of the Doonhamer Classic Rally. This year, we are delighted to welcome back our enthusiastic sponsor The Blue Door Dental Practice from Dumfries.

Thanks also to the other landowners & officials in advance who have helped to create this Doonhamer Classic Rally.

The start & finish venue will be at Lockerbie Lorry Park DG11 2SL on service road near Lockerbie where there are one test site. The 2019 route uses all of our already well-established venues, connected by classic quiet roads in beautiful South West Scotland.

During the event you will be challenged by 16 driving tests on a mix of tarmac, concrete and some smooth gravel, all of the "open" variety, with no reversing, designed to test the driver's skill and not mental agility. For 2019, we have striven to reduce gueues at tests starts by managing double usage.

Maps required to complete the route will be provided by organisers and there are no regularities.

At signing on, you'll will get food vouchers for both crewmembers for breakfast. Lunch Stop has to be confirmed which will be a snack meal at mid point area. Breakfast & Lunch meals are included in the entry fee; evening meal must be purchased in Lorry Park Café.

The truck stop offers ample room for trailers as well as competing cars but please park considerately as instructed by marshals.

1. Announcement:

The South of Scotland Car Club Limited will organise a Clubman's Historic Road Rally and Clubmans Targa Rally (with special tests), on Sunday 22nd September 2019, starting from Lockerbie Lorry Park DG11 2SL. It will be known as the Blue Door Dental Practice Doonhamer Classic and is a round of the NESCRO Championship.

2. Jurisdiction

The meeting will be held under the General Regulations of the MSA (incorporating the provisions of the International Sporting Code of The FIA) and these Supplementary Regulations. Clubman's Historic Road Rally and Clubman's Road Rally Permits have been applied for.

3. Crew Eligibility:

The event is open only to members of the organising club, the South of Scotland Car Club Ltd. Membership Forms For SOSCC are available on Regs /Entry Forms . **No competition licence is required.**

4. Vehicles Eligibility:

Vehicles must comply with section R 18-19 of the MSA technical Regulations, with the following amendments: R16.4.3 & R19.1.3 – Historic category 1 (R19.1.1) and Category 2 (R19.1.2) vehicles will be classified in the overall results, meaning that vehicles in classes H1, H2, H3 & H4 & C5 may win overall..

Cars in M6 Targa Class can only be classified in this class in accordance with the appropriate permit.(Can not win Overall) Those requiring waivers in accordance with R 19.5.4 must apply in writing to the Secretary at least three weeks before the event as these are to be dealt with on an individual basis.

Entries will be accepted for cars with non- period modifications when used in the interests of reliability and/or to overcome difficulties in sourcing period parts. This will be entirely at the discretion of the organisers and no debate will be entered into.

5. Start & Finish:

Lockerbie Lorry Park, DG11 2SL. Noise test, Scrutineering & Documentation commence from **08.00hrs** at Rally HQ.

Any competitor not signed on by **09.00hrs** may be excluded.

The first car will start at **9.30hrs** with subsequent competitors following at 1 minute intervals.

Details of a measured mile will be issued with the final instructions.

The total mileage will be approx' 90 miles based on OS 'Landranger' maps 78, 79, 84 85, latest editions.

The first car should return to the finish at the Lockerbie Lorry Park at approximately 15.30hrs.

6. Route:

Maps will be provided for the route.

7: Identification:

Cars will be identified by a rally plate which <u>must be affixed to the front of the car</u> and high-vis numbers which must be fixed to each side of the car. <u>Failure to comply with this will result in a non start.</u>

All marshals will be deemed Judges of Fact and driving standards observers will be out on the road sections.

8. Classes:

H1 Cars made before 31/12/1967 up to and including 1500cc

H2 Cars made before 31/12/1967 1501cc and over

H3 Cars made between 01/01/1968 and 31/12/1974 up to and including 1500cc

H4 Cars made between 01/01/1968 and 31/12/1974 1501cc and over

C5 Cars made between 01/01/75 and 31/12/1981

M6 Targa Class

If there are less than 4 cars entered in any one class the organisers reserve the right to amalgamate the classes as appropriate.

Only road pattern tyres (not gravel or town & country) are permitted. Close patterned road snow tyres E marked are, however, acceptable.

9. Entries: The entry list opens on publication of these regulations and closes finally on Wednesday 18th September 2019.

The maximum number of entries will be 50 and the minimum number will be 20.

If there are less than 20 entries received, the organisers reserve the right to cancel the event.

All entries are on a "first come first served" basis and should be forwarded to the entries secretary together with the correct entry fee and insurance fee, if required. Cheques should be made payable to 'South of Scotland Car Club Ltd' and may be post-dated to September 18th (but no later) if required. **Please note, No fee – no entry!.**

The entry fee is £90 and includes, 2 Breakfast Vouchers and 2 snack lunch meals and a great days Motorsport of 16 tests . All entrants must be club member

In the event of an entry being withdrawn, notification in writing <u>must be received by the closing date</u> to ensure a refund (minus a £10.administration). After this date they will not receive a refund.

11. Results:

Provisional results will be published as soon as possible after the event in accordance with H35.

Any protest must be made in accordance with C.5.1 and accompanied by the £45 fee as stated in Part 3 Appendix 1.13.1. Results will be based only on the times and any penalties accumulated within the tests.

12. Penalties:

Marking and penalties will be as printed in section R 13 of the MSA General Regulations, using the time penalty system, except as modified below:-

The marking for tests and penalties for Intermediate and Finish Controls will be as follows:

Failure to hand in Time Cards at specified points. Exclusion

R 10.6 The marking and penalties for Special Tests will be as follows:

All tests are timed to an accuracy of less than one minute.

The lowest penalty assigned on a test. Test Target

Not attempting or not being ready to attempt a test when instructed. Test Maximum

Not performing a test correctly, (Wrong Test), or not completing a test or making a jump start. **Test Maximum** Striking a bollard, marker, barrier, wall or pylon or crossing the boundary of a test. **10 seconds per mistake**

Failing to cross or stop at any line or specified position as required. 10 seconds per mistake

For every second taken to complete a test. 1 second

The Clerk of Course, shall, at his discretion, have the right to impose a penalty on any competitor who causes or is part of a serious blockage on a Special Test, whether intentionally or otherwise, if his actions prevent any other competitor from completing the test competitively.

The maximum penalty (including time) for any Special Test cannot exceed the Test Maximum.

N.B. Regarding the 'wrong test' penalty if you make a mistake and pass the wrong side of a cone or marker, you can stop and retrace your steps and this will not be counted as a 'wrong test'. However, should you pass 2 cones/markers incorrectly; you will automatically get the penalty for a 'wrong test'.

Failure to follow the instructions of an official. 5 minutes

13. Awards:

1st Overall by being fastest cumulatively on all tests (Only Competitors in classes H1 to C5 are eligible for the Overall Award). An Award.

1st in each Class. An Award. (No crew may win first overall and a class award).

First Lady. An Award.

First all-SOSCC crew who were Fully Paid 2019 members, prior to May 2019. An award.

Best presented car (decided by the organisers). An Award.

14. Breakfast Meal will be served within Lorry Park Café; also toilet facilities and shop are within building.

15. Insurance:

Vehicles must have Insurance in place which provides Third Party Liability cover that complies with the Road Traffic Act. This can be either, by extending an existing motor policy to cover the event, or, by purchasing additional cover as an adjunct to an existing motor policy.

If a competitor uses an extension to an existing policy, they will be required to sign a declaration that the cover complies with the requirements of the Road Traffic Act. Any responsibility for a fraudulent or misleading declaration about existing cover lies with the competitor.

If a competitor wishes purchase additional cover via the organisers then they can do so prior to the event providing they comply with the following.

Age 19 years or over

Has held a full licence for a minimum of 6 months

Has no more than 6 points on their licence

Has had no more than 1 fault claim in the last 3 years

The vehicle has valid Tax, MOT and is currently insured for road use

Anyone aged less than 19 years old will also be accepted at the same price should their co-driver be a more senior member of their family or over 25.

Any competitor who falls outside these parameters may be offered cover at equivalent terms or an agreed price, if approval from Reis Motorsport Insurance has been obtained by the event organisers, prior to the event. Additional cover provided by this scheme is only effective whilst the vehicle is actively competing in the event, and remains under the control or direction of the event organiser(s). Cover will cease immediately if you are precluded, excluded or retire from the event.
